1st Annual Manayunk EcoArts Festival

The First Annual Manayunk EcoArts Festival invites you to participate in a "green" celebration of artistic, sustainable and local initiatives. Over the course of two days, artists, regional green businesses and ecologically concerned community groups will expose visitors to a creative and educational experience. Join us in teaching the world how to live a healthy, and earth friendly lifestyle.

The EcoArts Festival is the natural expansion of our successful 21 year-old Manayunk Arts Festival. This new fall event builds upon our June Festival that is the largest outdoor juried craft show in the region, with exhibits by 300 artists and craftspersons and is attended by as many as 300,000 visitors over two days.

FEES

Jury Fee:

\$30.00 for paper applications (non-refundable)

\$20.00 on zapplication.com (non-refundable)

Exhibition Fee:

\$295.00 (2 days)

For those applying by paper application, your Jury and Exhibition fees must be submitted with your application in two (2) separate checks. A \$10.00 fee will be charged for all checks returned for insufficient funds.

Jury Fees are non-refundable. Exhibit fees will be returned to artists whose work does not meet the eligibility criteria.

All cancellation requests must be submitted in writing by **SEPT 1, 2010**. There is a \$25.00 fee for show withdrawals.

ENTRIES

Open to all artists who design and produce their own work sustainable and ecologically conscious work. Commercially mass-produced items will NOT be accepted. All exhibiting artists must be present at the two-day rain or shine event.

DISPLAY SPACE

Each participating artist will be provided with a 10' x 10' exhibiting space. Electricity is NOT available. Security will be provided overnight on Saturday, and displays may remain standing. However, it is advised that merchandise be removed. The Manayunk Arts Festival assumes no responsibility for any loss or damage.

JURY PROCEDURE

Applications must be accompanied by 5 high quality images, 4 representing the quality of the work to be exhibited and 1 overall view of your booth display. Each image must be accompanied by a small summary that details the workmanship of that artwork and must describe how the materials used are renewable, reusable, and recyclable. Digital images on CD are accepted; do not send slides.

Images MUST be current and properly labeled with your full name. **Applications without images or that do not meet the above criteria will be disqualified and returned. The application fee will NOT be refunded.**

DEADLINE

Applications must be submitted and postmarked on or before **AUGUST 31ST, 2010**.

NOTIFICATIONS

Artists will be notified by **SEPTEMBER 15TH, 2010**.
